AND WHEREAS the purpose of the Hearing is for the Commission to consider whether it is in the public interest for the Commission to:


1. pursuant to subsection 134(5) of the Act review the Commission's temporary order dated July 14, 2011 (the "Temporary Order"); and
2. make such other order as the Commission considers appropriate;

AND WHEREAS pursuant to an application under subsection 134(3) of the Act by staff of the Commission dated July 19, 2011, for an extension of the Temporary Order without a hearing, until such time as a hearing is held and a decision is rendered, the Commission issued an order dated July 20, 2011, extending the Temporary Order until a full hearing is held and a decision is rendered by the Commission;

TAKE NOTICE that the Hearing is adjourned to a date to be arranged by the Secretary of the Commission.
